

內政部國土測繪中心測繪成果電子資料流通作業要點

- 一、內政部國土測繪中心（以下簡稱本中心）為促進測繪成果電子資料之流通及資源共享，特訂定本要點。
- 二、本中心測繪成果電子資料之申請、供應、授權使用目的、閱覽及相關事宜，依本要點規定本要點未規定者，得適用其他法令之規定。
前項申請含首次申請及申請更新；授權使用目的含加值型、非加值型及開放資料。
前項申請更新係指第二次以上（含第二次）申請同一空間範圍之同項目更新資料。
第二項加值型係指以獲取利益為目的，將測繪成果電子資料改作或編輯而得之成品或加值衍生品，經有償贈與或交易，且所得應課徵所得稅等法定營利性行為，達到公開形式之傳播或發行等加值利用目的者。開放資料係指以無償方式、不可撤回，並得再轉授權方式授權利用者。
- 三、本要點所稱測繪成果電子資料類別如附表一。
- 四、測繪成果電子資料提供內容如附表二。
提供電子檔資料時，應一併檢附詮釋資料。
- 五、測繪成果電子資料提供對象及申請方式如附表三。
前項附表內所需各申請書格式如附表四至附表十五；管制同意書格式如附件一；線上申請流程如附件二；加值利用規定同意書如附件三；減徵規費切結書如附件四。
- 六、提供電子檔資料，應視申請之資料量大小，選擇以網路或儲存媒體交付。
前項儲存媒體及申請圖籍資料，申請人得選擇臨櫃領取或郵寄。
提供限制公開測繪成果時，應加密處理、標示機密等級及編號，以儲存媒體臨櫃交付為限申請人領件時，應查驗本中心同意提供及證明保管人身分之文件。
- 七、有下列各款情形之一者，應通知申請人於收受通知之日起十五日內補正：
 - （一）申請人資格不符第五點規定。
 - （二）申請文件不合程式或內容欠缺，或不完備。
 - （三）未依規定繳納規費。
- 八、受理測繪成果電子資料申請使用，應於受理申請之日起三十日內，為準駁之決定；必要時，得予延長，延長之期間不得逾十五日。
前項申請有下列情形之一者，得予駁回：
 - （一）申請提供項目不符第四點規定。
 - （二）申請使用目的不符相關法規。
 - （三）屆期未補正或補正不完全。辦理限制公開測繪成果之申請使用應報原機密等級核定機關同意。
- 九、申請使用測繪成果電子資料應依國土測繪成果資料收費標準繳費。
繳費方式得以臨櫃、電信網路線上付款或金融機構代收等方式辦理。
變更非加值型申請案為加值型申請案，應另繳差額。
全套分二次申請案，各次收費以全套總價之半價徵收。
- 十、申請使用測繪成果電子資料應簽署同意資料使用注意事項，其方式如下：
 - （一）非加值型申請案應於申請書簽名同意遵守所載資料使用注意事項，經線上申請確定者視同完成簽署。
 - （二）加值型申請案應簽訂加值利用規定同意書。

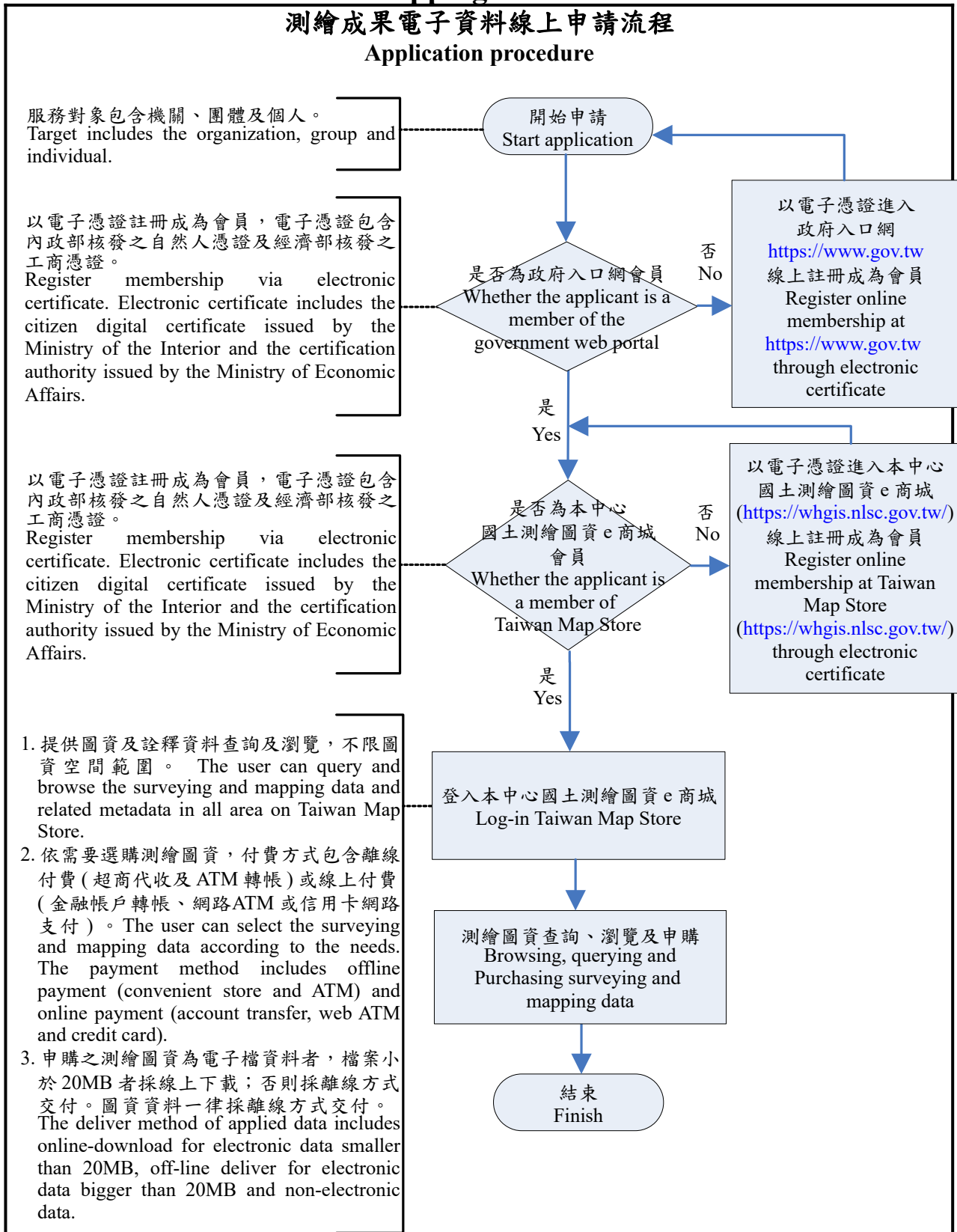
